Bar Services: Odessa Fire Company (OFC) is fully insured and licensed by the State of Delaware to serve beer, wine, and other alcohol for your event. OFC is required by law to obey all the laws and regulations pertaining to the service and the distribution of alcohol. OFC staff and management reserves the right to refuse service at any time or to any person. OFC requires the use of our bar staff for your event if alcohol is ordered. This service ratio may be subject to change based on the specific service requirements of a given event.

Payments: All payments for servers and prepaid alcohol must be paid 10 days prior to event unless prior arrangements have been made with bar manager.

Bar Options and Prices:

- 1) Open Bar, Stock Liquor, Beer, Wine, Sodas—
\$16.00 Per Person for Four Hours (Minimum)

- 2) Open Bar, Top Shelf Liquor, Beer, Wine, Sodas—
\$18 Per Person for Four Hours (Minimum)

- 3) Draft Beer, Wine, Sodas
\$12.00 Per Person for Four Hours (Minimum)

- 4) Soda Only
\$5.00 Per Person for Four Hours (Minimum)

- 5) Cash Bar
\$1.00 per soda (no charge if beer wine and soda package is chosen)
\$3.00 per beer
\$4.00 mixed drinks (rail)
\$6.00 mixed drinks (top shelf)

All prices above are for a 4 hour bar.

Additional bar hours will be based on a per person/per hour rate

All prices above include all Bartender fees for up to 4 hours.

Additional hours are a charge of \$25 per hour per bartender.

THE BAR WILL CLOSE NO LATER THAN MIDNIGHT (12:00 A.M.) unless otherwise noted.

50% deposit is due at the time of signing the contract.
Balance due 10 days prior to the event being held.

BAR CONTRACT

The Lessee is responsible for their guest. No alcoholic beverages are permitted to be brought on the property of the Odessa Fire Co. of Odessa. No alcoholic beverages may leave the Odessa Memorial hall as well!!

Cost of the bar is per person, regardless of age, unless three years and under.

If you wish to have champagne or wine toast for all you guests, you will be billed for the champagne or wine per bottle.

No one under the age of 21 will be served alcoholic beverages. Please pass this on to the wedding party due to the dress code. Parents should obtain sodas and juices at the bar for those under 21. **Due to State law, bartenders reserve the right to check ID's upon request. No ID will result in not being served from the bar.**

We have the right to refuse anyone who is either creating a disturbance or intoxicated. The lessee will be responsible for any damages done to the Hall.

Bar prices are subject to change without notice, due to market price changes beyond our control.

You have the option to close the bar for one (1) hour during your event. If you choose to have the bar closed during the dinner hour – any and all drinks request will be the lessee responsibility.

As lessee of the hall, please be advised and responsible. Everyone attending your event must follow and abide all laws of the State of Delaware regarding the consumption and possession of alcohol. Anyone attending the event failing to comply could result in the termination of your event.
